Implementation of Elevated Level II Pandemic Flu and Other Infectious Diseases State Building Operations Protocol

On Thursday, March 12, 2020 Governor Hogan announced that all state government was raised to Elevated Level II effectively immediately. Until further notice all public access to state buildings, including the State House, will be restricted.

Building Protocol

- 1. State office buildings will remain open.
- 2. State offices open to the public may put in place limited hours or appointment-only procedures in order to reduce foot traffic.
- 3. Access to the Maryland State House is limited to State Employees with State issued ID Badges and individuals accompanied by someone with a Maryland State Employee Badge (Employees, lobbyists, contractors, media personnel, etc).
- 4. Access to other buildings in Baltimore or the Annapolis Complex should be limited to State Employees with State issued ID Badges, as the general public should be encouraged to contact legislators or other state officials via email or phone. This does not limit the general public from entering these buildings.
